Confirmed guest speakers are Australian entomologist **Dr Garry Levot**, principal research scientist, microbiological diseases and diagnostic research, at the Elizabeth MacArthur Agricultural Institute in New South Wales. Garry leads research into the control of animal ectoparasites and also the small hive beetle, an exotic pest of bee hives.

Lincoln College **Professor Susan Worner** will be presenting a paper on biosecurity, looking at modelling and mapping to predict which insects and pest species might arrive in New Zealand, where they could establish and what impact they would have on NZ agriculture.

**Professor Robert Poulin**, leader of the wildlife parasite research group at Otago University will also be addressing the conference.

### CONFERENCES AND CONFERENCE FEEDBACK

WAAVP Conference 21 – 24 August 2011 Buenos Aires

The 23rd WAAVP conference was held during late August in Buenos Aires, Argentina. The conference attracted approximately 760 delegates from around the world including 50 from Australia and New Zealand. The NZSP was represented by, among others (and apologies to those missed off this list), Bill Pomroy, Ian Sutherland, Andy Greer, Robin McAnulty, Trevor Cook, Barry Hosking, John Moffat and Tom Watson. There was a good variety of topics during the oral, poster and symposium sessions during the four days of conference and overall the Argentinians ran a tight show. There was a concern that the conference would be dominated by livestock parasitology but at the end there was a significant companion animal component as well. We were well fed (the average steak was probably close to 500 g) and watered (often with a very nice Malbec), and also entertained with a live natural history show before the gala dinner. A number of delegates stayed on in Latin America after the conference to visit what are some very nice countries.

The Peter Nansen Young Scientist Award was won by Laura Rinaldi (Italy), while Jozef Vercruysse (Belgium) and Lyddon Polley (Canada) were awarded the Bayer Prizes for their contributions to parasitology.

Peter Holdsworth (Australia) is the new President of the WAAVP and **Bill Pomroy** will continue for a further two years as the Secretary/Treasurer. **Barry Hosking** was elected to the Executive Committee.

The 2013 conference will be in Perth and it was announced that Liverpool, UK won the bid for the 2015 conference.

#### **Instructions for Authors for the Preparation of Abstracts**

The abstract should be self contained, readable and easily understood by people not intimately involved in the field. The abstract should contain clear objectives, appropriate data (with statistical parameters such as standard error of means or probability estimates) and conclusions as appropriate. Unnecessary jargon and abbreviations, and information not relevant to the objectives and conclusions should be avoided.

#### Please ensure that:

- 1. The title and names of all authors are provided.
- **2.** The name, address, phone, fax number and email address of the corresponding author are given to facilitate contact regarding your submission.
- **3.** The abstract is set (excluding title and authors) in 12 point Times Roman. A maximum of 300 words is allowed. **Do not include headings, tables, equations or references.**
- **4.** If possible please submit the abstract electronically to the Abstracts Editor. The abstract form can be requested from the Secretary. Email the abstract in Microsoft WORD format to the Abstracts Editor. The abstract may be mailed to the Abstracts Editor if you do not have access to email.
- **5.** Abstracts must be received by the **15th September 2011**.
